#### PRESIDENT'S MESSAGE by MCANJ President John M. Mitch



On behalf of the Executive Board and our Executive Director, I extend to you our best wishes for a Happy and Healthy New Year, and hope that you were able to enjoy the holidays with family and friends.

For municipal clerks and county clerks, ringing in a New Year often brings additional workload in tandem with our reorganization meetings, especially with the countless appointments and reappointments that are made by our governing bodies. While this meeting does consume a lot of our time, it too will pass as we're already working on the next tasks upon us.

Having just completed twelve months as your President, I want to thank you, the general membership, individually and collectively, for your continued support and encouragement this past year. Having conducted five (5) Executive Board Meetings, four (4) Advisory Board Meetings and several Conference Committee Meetings during the 2014 calendar year, we have worked together as a team to put forward some new initiatives while, at the same time, tweaking other practices, all in an effort to serve you better and more efficiently.

In the past, the January Quill edition would have included a State of the Association Message from your outgoing President as well as a Welcome from your incoming President. However, with the change of our association from a calendar year to a fiscal year

operation, the terms of our Executive Board members as well as your Advisory Board members and all committee members have been extended until June 30, 2015. This change, as well as the postponement of collecting dues, will likely be the most transparent changes, with the latter being equivalent to six-month additional membership at no cost. What you do not see is the retooling and updating of our primary job responsibility timelines for all Executive Board members and several of our committees.

While the aforementioned were borne out of the change to our operational year, other changes have been made to our internal controls by implementing a segregation of duties and instituting a stronger alternate control, both at the suggestion of our underwriters.

With the New Year, we will be launching the on-line registration system for MCANJ sponsored mini-conferences, much like we did with MCANJ membership and MCANJ's Annual Education Conference. The on-line mini-conference registration will track registrations and payments, provide an invoice, and allow for electronic issuance of CEU certificates. Like the first two on-line systems, this too will be tied to the membership database and for those who want to register but are not MCANJ members, you will be prompted to either register your membership, or be subject to paying non-member fees. The system was tested by the Executive Board and Advisory Board members in November and all worked well. A lot of thanks are directed to 2nd Vice President Denise Szabo and IT Committee Chair Daina Dale for their continuing efforts with these changes.

Over the summer I made a concerted effort to attract more members. As I sat to prepare these comments, our membership to date totaled 793; up 54 from this time last year however, down 25 from the prior year. While I am not certain what caused this number to fluctuate so much, I remind you that our membership dues have remained stable for quite some time and that in order to attend MCANJ-sponsored education sessions at a member rate, your membership dues must be current. With the annual Education Conference only three months away, it is important that you are a paid member in order to attend at the member rate.

Our Information Technology / Webpage committee (Daina Dale, Jim Doherty and Andrew J. Pavlica) continue to use our website (www.njclerks.org) and Facebook Page to communicate with our membership so that we are sharing as much as possible with you. You should also be reminded that our meeting minutes are posted on our website, which allows you to follow along with what's happening and to see what items your Executive Board Members and Advisory Board Members are discussing on your behalf. We are also considering, at the request of an MCANJ member, additional enhancements to the site which may include a Resolution database for your use. Discussions continue about how to set this up and how to categorize the Resolutions. This past year our website was used for on-line polling of members. This exercise can be extremely helpful to the Executive Board when considering changes. In fact, referring to the suggestion of a Resolution database, of 126 members who cast their vote last time I looked, 92% (118 votes) indicated that they would use the database if it were created. 1% (1 vote) and 7% (9 votes) voted no or not sure, respectively.

By the time you receive this issue of the Quill, the 99th Annual New Jersey State League of Municipalities (NJLOM) Conference will be long past. Please do not forget to access your CEU certificates through their website. While there will likely be many reminders to do so, don't postpone accessing them as there will be a deadline date that you do not want to miss. Otherwise, you may not be able to get the credits you earned and deserve. Many thanks go out to NJLOM Executive Director William (Bill) Dressel and his team who consistently put together outstanding conferences. Next year's 100th will certainly be a milestone to celebrate. The amount of work that goes into an undertaking like this is unmeasurable. I also want to thank MCANJ 1st Vice President Keith Kazmark for working with our Education Committee (Joanne Kwasniewski, Harold Wiener, Ann Marie McCarthy, Heather Mailander, Gene Padalino, Sharon Young, Linda Wanat and Louise Palagano) by participating in Joint Sessions with other disciplines as well as presenting three sessions for our members which included ABC Exceptions, What's Hot in the World of Elections, and The Quest for Government Integrity. For those of you who may not have been able to attend her session, we will have her at our annual Education Conference in April.

Much thanks to MCANJ Secretary Kevin Galland and Executive Director Joel Popkin for working with the Executive Board in ordering the booth and to Public Relations Co-Chairs Barbara Rae and Ceil Covino for their assistance. They also helped coordinate the volunteers who helped cover the booth during the conference which included active members and retirees including Manny Hirshblond, Bette Mastropasqua, Joan (and Rich) Moreland, Joel Popkin, Heather Mailander, Joanne Kwasniewski, Michele Bobrowski, Debra Sopronyi, Marie Elena Macari, Joan Hullings, Shinnell Smith, Joyce Lanier, and Deanna Bennett (I hope I didn't miss anyone). In addition, I thank Kevin Galland for covering the General Consulting Period and availing himself to municipal officials from around the state who may have questions about Municipal Clerks.

In the last Quill, I spoke of our 2015 Annual Education Conference (Motivation Matters!). Since then, due to the uncertainty of the Taj Mahal in Atlantic City, we have moved our conference to the Tropicana Hotel (Atlantic City). Registration, one class and a welcome reception will kick off the conference late-afternoon, Sunday, April 26, 2015. The conference will end late-morning, Wednesday, April 29, 2015. In between will be a number of General and Break-Out Sessions to help you obtain your CEU's. Details and registration for the conference is expected to be announced this month. It will be sent out via e-blast to our members and posted on our website and through Facebook. I am hoping that this conference is as equally if not more productive than my conference as President last year; Municipal Clerks: Meeting the Challenge. I like to think that last year we "met" the challenge and this year, we will become more motivated than ever.

I would also be remiss if I did not thank those of you who recommended other locations to look at for our conference. However, after contacting each facility, most of which were outside of Atlantic City, we continually ran into problems with date availability, prices, lack of rooms for overnight accommodations, limited meeting space, etc. Once we block out dates for work-related conflicts (petitions, elections, etc.), holidays (Easter, Passover, Memorial Day, Mother's Day, Father's Day), and other important times of the year (i.e., communions, graduations, etc.), it leaves little availability on the calendar for us to select conference dates.

As for legislation, there continues to be countless Bills under consideration by the Legislature of which OPRA, OPMA and the GRC Bills are among them. Immediate Past President Nancy Saffos and I have participated in several discussions and meetings with the League and other interested parties with regards to S-781(OPMA) and S-782 (OPRA) [sponsored by Senators Loretta Weinberg and Joseph Pennacchio] and how they are tied to the 2004 Privacy Study Commission Report. While these Bills seem to drag on and on, I can't help but to think it may be to our benefit. Another Bill that we are concerned with is S-2324 which would permit municipalities to enter into a professional services agreement for newly appointed Tax Assessors. As I mentioned to one of our committees, if this was to become law, it begs the question: Who will be next? There is some good news with the A-3390 (sponsored by Assemblyman Craig Coughlin). This is the Bill that allows the Municipal Clerk the option to transmit Land Use notices to adjoining municipalities and the County Planning Board electronically. This Bill too was at the suggestion of one of our association members. While the Bill was moving forward it did hit a snag with some wording with reference to confirming service / receipt. Our Legislative Review Committee for Laws Pertaining to Municipal Clerks (Kim Marie White, Harold Wiener, Rhona Bluestein, Susan Robostello and Kelley Halewicz) have weighed in on this and will continue to monitor movement on this and the many other Bills out there. You can always view their reports on our website and see the amount of time and dedication they put in which is evidenced by their reporting. In addition to this committee, Michele Seigfried (Robbinsville) represents me at the Leagues Legislative Committee meetings which she and other Municipal Clerks including Nennette Perry (East Brunswick) and Mike Januszka (Milltown) participate in with the decision making as to what Bills the League supports or opposes.

I am also sure most of us are anxiously waiting to hear about what will come upon us by Executive Order or Legislation regarding "more" reforms to our pensions and health benefits. We still await the Study Commissions report and recommendations as well as any word from the state as to the direction they will be heading.

Several months ago I heard that there may have been one or more Municipal Clerks who thought that they were automatically a Notary Public by nature of their position. Please know that our attorney (Richard Lustgarten) has opined that it is not the case and that a Municipal Clerk would have to apply for that designation like anyone else. While state statutes authorize the Municipal Clerk to administer oaths in certain circumstances, a municipal clerk does not have general notary powers unless qualified under NJSA 52:7-10 et seq.

Desk Reference (Update No. 4) is completed thanks to committee members Joel Popkin, Deanna Bennett, Ann Bistritz, Judy Allen and Nennette Perry. They have worked hard with the RMC instructors on this update which in part includes a complete overhaul of Chapter 4 (Records Managements and Open Public Records Act), specifically in the area of Records. For immediate access, please visit our website. It will also be incorporated into the materials the students will receive upon registering for the Introduction to the Duties of the Municipal Clerk session this spring.

We learned in November of some policy changes that the International Institute of Municipal Clerks (IIMC) was making with regards to those seeking the CMC designation. The concerns were with those earning the designation prior to January 1, 2015 and those after. Those after this date would receive 47 education points towards their designation after completing the five RMC Rutgers classes as compared to those who received their designation prior to that date who would only receive 20 education points. This change is of concern to many clerks who have expressed their disappointment with our IIMC representatives. To that end I am sure both IIMC 1st Vice President Vincent Buttiglieri and Region II Director Andrew Pavlica will be addressing this matter and will report on it in the upcoming months.

Over the past several months I have had the opportunity to attend a number of retirement celebrations. Among them was one for Jane E. Williams-Warren (City of Paterson) which was held at the television-famous Brownstone. While driving to her dinner, I could not help but remember the amount of her family members and friends who showed up on stage for her crowning as Clerk of the Year several years ago. With that said, I was not surprised to see the more than 200 people in attendance at her dinner.



#### CIVILITY, THE FIRST AMENDMENT AND COUNCIL MEETINGS

In 1756, Lady Mary Wortley Montagu said "Civility costs nothing and buys everything."

Senator Adlai Stevenson said "Politeness is the art of choosing among one's real thoughts," and in the immortal words of comedian Jimmy Durante, "Be nice to people on your way up because you might meet 'em on your way down."

These sentiments seem to be largely lost in today's public discourse. We have a congressman interrupting the President when he was addressing Congress and an Associate Supreme Court Justice shaking his head negatively when the President was referencing a Court decision.

Whatever happened to respecting the office even if you have dislike for its current occupant?

Closer to home we have a Governor who seems to relish "in your face" confrontation with residents, students and reporters. "Sit down and shut up" is not constructive discourse but makes for good press and may confirm ones "toughness." The problem of perceived lack of civility crosses the political spectrum and is neither Democratic nor Republican in nature.

Benjamin Franklin said "Be civil to all, sociable to many, familiar with few, friend to one, enemy to none."

And finally "A good word is an easy obligation, but not to speak ill, requires only our silence, which costs us nothing." (John Tilotson, Archbishop of Canterbury)

So where have we lost our way, according to some?

The First Amendment to the Federal Constitution provides that Congress shall not abridge the freedom of speech, and most states have similar provisions in their own Constitutions.

We know, of course, that the "freedom" referenced is not absolute. You can't yell "fire" in the crowded movie theater, and terroristic threats, and threats to do bodily harm with the clear capacity to do so, are criminalized in our statutes. Obscenity is an offense that can be prosecuted, and slandering someone is actionable.

Other than these and some other limited categories, does this mean that anything goes as far as speech is concerned? Can municipalities limit comments from the public at meetings and if so in what way?

We start with the premise that a full and open discussion of public issues that foster and support transparency in government is a worthy goal, at that the public has the right to address its elected and appointed officials on virtually all topics relating to the manner and style of governance, as well as questioning specific topics such as taxes, expenses, projects and the hundreds of other matters that Mayors and Council members deal with all the time.

But where does critical inquiry end and scurrilous attack begin? Can the public be shut down because the comments are incorrect, insulting, off base, political, grandstanding, or just a plain "waste of time?"

Some communities are introducing ordinances to limit public comments to "relevant" matters and to have the inquirer direct questions through the chair (Mayor) rather than to a specific elected official. We know that by statute public comment is required at every council meeting, and mandated public hearings are required for the adoption of ordinances.

We also know that reasonable time limitations can be imposed for these comment periods. But what kind of limitation, if any, can be instituted when the comments are truly irrelevant, nasty, in the attack mode, or plainly uncivil given the requirements of the "free speech" clauses and the desirability to achieve as much "open government" as possible?

Case law indicates that there may be a restriction on "speech" using a time, place and manner test. That is to say, despite some residents' thoughts to the contrary, you don't have the right to speak whenever you want to. The speaker is out of order in addressing the Council outside of the allotted public comment periods and may be prosecuted not for what is said, but rather because it is being said at an inappropriate time and is disruptive of the meeting.

"Time, place and manner" speech cases involve some very delicate balancing between the competing interests of the right to be heard and the right of a society to conduct its business in a safe and orderly manner.

An example would be billboards which are a form of commercial speech. The place, size and type of billboard may be regulated, subject to certain conditions, and this is not deemed to be a speech violation as long as the content of the sign is not restricted.

But I digress.

The prevailing view is that the concern over civility is subordinated to the public's right to redress grievances against the government.

Harry Truman supposedly said "If you can't stand the heat get out of the kitchen." Though sometimes used in a humorous context, this is an unfortunate comment because it places the burden on the receiver of abuse to endure it, rather than on the abuser who promulgates it to forego it.

So where are we?

The right to comment, even as offensively as can be imagined, must be tolerated so long as the comments are not disruptive. If a public official (elected member) or public figure (some staff members) feel they have been unfairly slandered, the right of redress is a difficult one. Unlike an ordinary citizen, for the last fifty years since *NY Times v Sullivan*, you have to prove that the speaker made the comments with actual malice (whatever that means) instead of just being fast and loose with the truth or careless with the facts.

Enduring hurtful words and accusations are the price of democracy, but I have always felt that public officials should not be the public whipping boys or girls of every malcontent, political opportunist or truly demented individual who wishes to make a splash at a Council meeting in the hopes of having the comments printed in the local paper for that proverbial five minutes of fame.

I don't believe that public officials sign on to be abused just because they serve in government. Sometimes it's unavoidable, given our strong tradition of speech and open government set forth above.

In my capacity as municipal attorney and attorney for a board I drew the line if I was accused of an illegal act or acting unethically. If someone commented that my legal advice was wrong, politically motivated or just plain dumb, it rolled off my back. Attack me in the former categories and I fired back (civilly, of course) because no response is interpreted by some as an admission.

I thoroughly advise that the public should be afforded as much opportunity to have its say as is reasonably possible given the business at hand of the agenda.

I also believe, contrary to an editorial in a Bergen County newspaper, that the public should address the Chairperson and the comments can be funneled to the appropriate Council or staff member. I believe this makes for a more orderly process especially when a topic is expected to be unduly contentious.

I recommend to you an article sponsored by the NJ League of Municipalities entitled "The Need For Civility In Local Government Dialogue" by John C. Gillespie, Esq., Co-chair of the League's Municipal and Governmental Relations Dept.

Finally, when you're gritting your teeth and the comments are being made at a late night Council meeting, remember the words of Winston Churchill: "It has been said that democracy is the worst form of government, except all the others that have been tried."
