PRESIDENT'S MESSAGE by MCANJ President John M. Mitch



Within the next several weeks we will gather in Atlantic City for our Annual Education Conference (*Motivation Matters!*) at the Tropicana Hotel & Casino. For those of you who have put together our association's conference in the past, you know how much time and energy is involved. For those of you who have not, I encourage you to consider getting involved in the future as new ideas and faces are always welcomed.

While most conferences go off without a hitch, an issue came up last year that I hope does not repeat itself this year. Nonetheless, I want to share it with you so that if it were to occur again, I ask in advance for your understanding and patience. When planning any conference, the committee members target speakers for Elections, Finance, Licensing, Records, Ethics, Professional Development and Information Technology. We try to present refreshers on everyday tasks as well as cover new areas and requirements that are all too often tossed our way. We also attempt to get speakers that are engaging so that no one walks away feeling the session was a waste of their time. As you will recall from my previous reporting, Rutgers dismantled what we used to refer to as the MCANJ Education Committee. In the old format, there were 5 Rutgers appointees and 5 MCANJ appointees. For a number of reasons, Rutgers changed to an Educational Advisory Board with no MCANJ appointees. This all started in July 2014, when a new Program Coordinator at Rutgers was named — Laura Flagg.

To that end, Laura called a meeting in February where she, Dan Kaminski (DCA), most RMC instructors and representatives of MCANJ including myself were all at the table to discuss a number of items, including class enrollments, the state exam, course updates, continuing education, instructors, Athenian Dialogue, and more. Most important in my opinion was the discussion of the low passing rates on the most recent RMC exams (October 2014 @ 27% and April 2014 @ 33%) and what changes might be considered for future test takers. I want to thank Laura Flagg for calling this meeting and Dan Kaminski, Joel Popkin, Joanne Kwasniewski, Deanna Bennett, Sharon Young, Jennica Belici, Kim-Marie White, Drew Pavlica, Bob Sloan, Mary Madonna, Elaine Kennedy, Jim Doherty, and Mark Mutter for participating. While there were several invitees who could not attend, Rutgers is planning on another meeting over the summer and MCANJ will once again be happy to participate.

On the legislation front, MCANJ 2nd Vice President Denise Szabo and I participated in a conference call with the NJLM (Lori Buckelew) to discuss proposed changes by the Division of Revenue and Enterprise Services (DORES) [formerly DARM] regarding records management practices by municipalities. Of paramount importance to us was the need for DORES to clarify some of the regulations they are proposing. We thank the NJLM for inviting us to join them in responding to the proposed rule changes which were due at the beginning of March.

I also shared with you previously, my interview with NJTV regarding OPRA. I have placed several calls to the office of Senate Majority Leader Loretta Weinberg to discuss where she is with the long anticipated changes to OPRA, to no avail. I can't even get a return phone call at this time. However, my television interview received attention and support from a number of unlikely sources including the Atlantic City Press; in the form of an Editorial. They wrote that while they would normally push to expand OPRA regulations, the commercial use of OPRA (a/k/a data mining) is causing "unintended, and unfortunate, consequences, along with untold labor for municipal clerks." They continued to state that the current situation is not what legislators intended when they wrote the law to help citizens keep track of public records and suggested that the law be revisited and be adjusted, depending on how it is being used and "abused". I am also encouraged that a trustee for New Jersey Federation for Open Government (NJFOG) has taken an interest in the data mining issue and has spoken to his members who have the ear of a legislator who is working on his own OPRA changes. This subject is very dear to us so this too must continue to be monitored.

Relative to OPRA, I try to follow many ongoing cases including one currently making its way through the courts that involves

Tabernacle Township. There, the Clerk redacted personal financial information from a record being sought. The requestor has taken it to a higher authority and we now await the ruling. This is an interesting case to follow.

As for tenure, while there is nothing in the hopper that I am aware of, the term is always floating about. In a recent matter, a town opted to not reappoint its municipal clerk but at the same time, did not dismiss the clerk. Our attorney has opined on several occasions that the applicable statutes do not provide for a holdover status. It provides for a three-year term and that tenure is achieved if a clerk has served for 5 consecutive years; in other words, he / she obtains a second three-year appointment. If no appointment of the incumbent clerk occurs within 60 days after the expiration of the previous term, the clerk would, upon appointment after the 60 day window, be considered a new appointment.

During the month of January, I attended the IIMC Region II Conference in Dover, Delaware where there were a number of New Jersey municipal clerks in attendance. Kudos to the Delaware Municipal Clerks Association who put on an exceptional Conference for all of Region II, and hats off (no pun intended) to our very own Pat Frontino (Glassboro) who took first place in the derby hat competition. Like I said before, it can't be all work and no play.

In the past I have reported at least twice about the Governor's ninemember New Jersey Pension and Health Benefit Study Commission which recently issued a "Roadmap to Resolution". As some of you may have heard or read, the Governor spoke about this and public employees' pensions and health benefits during his 2015 State of the State address. Since that address, several more lawsuits have been filed by various unions regarding the State's obligation to make their pension contributions. The report has raised the eyebrows of the NJLM to which they have scheduled a joint meeting of the League's twenty (20) Affiliate Associations to discuss. Please know that MCANJ will be represented and that we will report back to our members accordingly. One of the League's concerns about implementing the roadmap is the potential for a mass exodus in local government. This in itself will create a significant impact with new issues and concerns for local government. One of our goals is to protect our members' pensions. As employees, we never had the option to skip a payment like the state did. Therefore, we should not be penalized. Another concern is the out of control increases with health benefit contributions. That too must be addressed now, and not later.

In closing, it has been my pleasure to serve as your President for the past 15 months. I promise to continue representing you to the best of my ability, and will work with 1st Vice President Keith Kazmark as he transitions to the Presidency on July 1, 2015. As I pen this report the first week of March, we are just hours away from another significant snow event. Let's hope and pray that by the time you receive this, the snow and its remnants will be long gone.

PROPOSED CHANGES TO BY LAWS AND CONSTITUTION

At the Municipal Clerks' Association of New Jersey's Annual Business Meeting to be held on April 27, 2015 in the Tropicana Resort and Hotel in Atlantic City, the following proposed changes to the Association By Laws and Constitution Shall be Given Consideration.

EXPLANATION: Matter UNDERLINED thus is new matter. Matter contained in BRACKETS [thus] is to be omitted.

MUNICIPAL CLERKS' ASSOCIATION OF NEW JERSEY, INC. CONSTITUTION AND BYLAWS

CONSTITUTION ARTICLE I

Section 4. Fiscal Year

The fiscal year of the Corporation shall be July 1 – June 30.

Section [4] 5. Dissolution

Upon the dissolution of this Association, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a State or local government, for a public purpose.

ARTICLE III - OFFICERS

Section 6. Indemnification of Officers

2. The Association shall indemnify an officer against liability for any settlement, judgment, fines or penalties to the extent that the officer has been successful on the merits of the matter or otherwise in any proceeding [referred to] which in the judgment of the Association, the officer has met the standards set forth in subsection 1.A. and 1.B. above, or in defense of any claim, issue or matter therein.

Indemnification for liability for any settlement, judgment, fines or penalties in any case not described in paragraphs 1.A. or 1.B. Hereof, may be made by the Association only as authorized in a specific case upon a determination that indemnification is [prior] appropriate in the circumstances because the officer met the applicable standard of conduct set forth in subsections 1.A and 1.B above. Said determination shall be made by the Executive Board as constituted under Article IV, Section 1. of this Constitution, except that no officer seeking indemnification shall participate in any manner whatsoever.

ARTICLE IV - COMMITTEES

Section 2. Advisory Board

1. ...

A. The Annual Meeting shall be held during the Annual Education Conference (March or April), at the call of the President. There shall be <u>no fewer than</u> [at least] three (3) Advisory Board Meetings held during the fiscal year [at the discretion of the President] for which the date and location shall be determined by the President.

ARTICLE VI - ELECTIONS

Section 1. Nominations

3. All candidates shall have tenure of office, shall have experience and training for that office, shall have received the [degree] <u>certification</u> of Registered Municipal Clerk (RMC), and shall be actively employed as a Municipal Clerk.

BYLAWS ARTICLE I - MEETINGS

Section 1.

The Annual Business Meeting shall be held in conjunction with the Annual Education Conference (March or April) at the call of the President. There shall be <u>no fewer than [at least]</u> three (3) Advisory Board Meetings held during the fiscal year[at the discretion of the President] for which the date and location shall be determined by the President.

ARTICLE V - RULES OF ORDER

Section 1.

Robert's Rules of Order shall govern all proceedings insofar as they are not inconsistent with the Constitution and Bylaws.

[REPEALER] EFFECTIVE DATE

Section 1.

These Bylaws, as amended, shall become effective [March 27, 2014] April 27, 2015.

[Section 2.]

[All sections of the Bylaws of this Corporation that are inconsistent with these Bylaws be and they are hereby repealed.]

POTPOURRI

We are all familiar with the requirement of providing "adequate notice" for public meetings that are not included in the "annual notice" of meetings.

What exactly is "adequate notice"? The term is defined in N.J.S.A. 10:4-8d. In pertinent part, the statute states that written advanced notice is required of at least 48 hours before the proposed meeting setting forth the time, date, location, and, to the extent known, the agenda to be considered.

The notice shall also include whether or not formal action may or may not be taken.

The notice must be prominently posted in the public place reserved for such announcements.

Notice must also be mailed, telephoned, telegrammed or hand delivered to at least two newspapers which have been officially designated for such purposes. (Notice may also

be supplied by the Internet but that process does not supersede the other methods and cannot be considered as a substitute for them.)

Some confusion has arisen with respect to the "transmittal" of the notice. The plain language of the statute can be read literally to mean that once the notice is sent, the statute is satisfied.

However, this interpretation does not advance the purposes of OPMA (open government, public's right to be informed and to participate, etc.) if the notice is sent timely as to the 48 hour requirement, but not in time for publication from a practical point of view. In other words, you need to know the publication schedule of the newspapers that you use to allow them to have time to publish the notice prior to the 48 hour requirement. Please note that you do not guarantee publication. That is up to the newspapers after you send a timely notice.

The requirement of timely notice for publication is now firmly embedded in our case law and must be followed. An example of what would not be good notice under the current requirements is as follows.

A special meeting is called for a Thursday. Notice is sent to the newspaper on the preceding Monday but it only publishes on Friday (after the meeting). The illusory "notification" does not satisfy the statute because, despite timely chronological transmittal, actual notice is an impossibility based on the papers publication schedule.

Finally, please note that for true emergencies where "adequate notice" cannot be transmitted, N.J.S.A. 10:4-9 provides relief so long as the safeguards contained therein are strictly followed.

Recently, a case was decided relating to placing a question on the ballot by way of referendum which was characterized by the Judge as having no legal effect on the litigants.

East Newark's governing body voted to have a non-binding referendum concerning where its students would go to high school since it did not have one of its own. East Newark had an arrangement with Harrison on a send /receive basis.

The East Newark Board of Education raised the issue with the Harrison Board of Education about terminating the arrangement, but Harrison took the position that East Newark had to follow the statutory procedure which required East Newark to submit a feasibility study to the Commissioner of Education. Please note that jurisdiction over students' education vested in the Boards and not the governing body.

Nevertheless, the East Newark Mayor and Council adopted a resolution authorizing the Hudson County Clerk to include on the ballot the question of whether or not East Newark should continue to send its students to Harrison or to Kearny instead. No interpretive statement accompanied the resolution. The County Clerk requested such a statement from East Newark and one was prepared by the municipal clerk and attorney, and sent to the County Clerk.

The Harrison Board of Education sued the Hudson County Clerk to enjoin her from including the question for the upcoming 2014 election.

The Borough of East Newark intervened and many issues were raised concerning jurisdiction and whether or not the question was one that could be considered by way of referendum.

Essentially East Newark argued that Harrison would not be legally affected by a non-binding referendum and Harrison argued that the East Newark Mayor and Council exceeded its authority as the educational issues were the province of East Newark's Board of Education.

There were other issues in the case such as standing to sue, whether the suit was time barred etc.

After the Court resolved the procedural issues raised by the parties, the substantive question was the division of power between a local governing body and a board of education.

The Court found that the governing body did not interfere which the internal workings of the Board and that the referendum question was proper. However, and this is why this case summary is being presented, the issue of the interpretive statement was also decided by the Court. While the Court discussed those types of questions which require interpretive statements, he decided that this one did not. Nevertheless, he also decided that the interpretive statement prepared by the aforementioned Borough officers was improper as it was not adopted by a resolution of the governing body.

When in doubt, have the governing body adopt or ratify and confirm your actions.

In your capacity as custodian of records you probably have come across legal documents called briefs, prepared by the municipal attorney or by opposing counsel. In current practice briefs are anything but, and I tried to ascertain the origin of the term.

The best I could find is that the term probably came from English legal practice. Before a case went to court, the preliminary work was done by a Solicitor and when it was ready for court it was turned over to a Barrister for handling. The Solicitor prepared a summary of the case for the Barrister in a concise manner---consequently the word "brief" evolved.


Today of course "briefs" can run upwards of 50 or 60 pages or more with supporting documents.

This runs counter to preparing a writing that will not only inform the reader but also keep his/her interest. The rule of brevity is also good to follow in municipal memos, letters, ordinances and resolutions. A pundit recently said that clear, concise and informative writing has more potential of actually being read than one which drones on. He described the latter as sleeping pills on paper. Aptly put.
