Also, it is worth noting that past BCMCA President Ann Fay (Haworth) re-read the speech her Mayor, Dean DeRienzo, gave when she was sworn in as President in 1993. This is always a great time and provides members the opportunity to meet and network with Municipal Clerks from the entire region!

Our own MCANJ Conference Committee is hard at work planning our 2016 MCANJ Annual Education Conference at the Tropicana Hotel and Casino in Atlantic City from April 24 – 27, 2016! Co-Chairs Sharon Brienza (Branchburg) and Heather Mailander (Ridgewood) along with the entire committee have selected retired Lt. Colonel Kevin Sweeney of the United States Air Force and Air National Guard as our keynote speaker. Lt. Colonel Sweeney spent 23 years serving our country and is the recipient of the US Air Force Distinguished Flying Cross. He is also the author of *Pressure Cooker Confidence* and *Conversations with the Colonel*. Lt. Colonel Sweeney was a keynote speaker at the IIMC Conference a few years back in Nashville, TN, and those of us in attendance were quite impressed with his session regarding high pressure situations. We will be launching our online registration beginning in February for the MCANJ Conference! Be on the lookout for the email blast announcing the start of registration.

Finally regarding conferences, the International Institute of Municipal Clerks (IIMC) 70th Annual Conference will be held from May 22 – May 25, 2016 in Omaha, Nebraska. Just another reminder that our very own Vinny Buttiglieri (Ocean) will be installed as the new President of IIMC at the conference and the Executive Board and I are encouraging New Jersey clerks to attend. We hope you can join us in supporting our good friend Vinny and be part of what is always a great educational opportunity!

On the legislative front, Governor Christie vetoed the Democracy Act which was promoted by the leadership in the Legislature. Senate Bill 2454, known as the DLGS "Streamlining" Bill, updates outdated policies and procedures

and is now in effect. Local Finance Notices addressing the various components of this bill have been and will continue to be forthcoming in order to guide local government officials as to the implementation of these changes. The discussion regarding changes to OPRA and OPMA have died down for now, however we have kept open the lines of communication with the League, other stakeholders and members of the Legislature regarding these two topics.

And finally, it is with great sadness that I inform you of the retirement of our longtime legal counsel Richard Lustgarten. Richard has been a tremendous resource to MCANJ and our members. His retirement to Indiana (although he's told us he will be back in New Jersey frequently) will leave a void that will be difficult to fill. Richard has offered to continue to speak at future CEU sessions, write for The Quill and continue to help MCANJ in any way he can. His departure re-



flects the same dignity, class and respect that he has shown during his years of service representing MCANJ. Once notified of Richards's retirement, I asked 1st Vice President Denise Szabo (Bernards) to help prepare an RFP so that we could advertise for our new association attorney. It was advertised in multiple locations and e-mail blasts were sent out so that we could receive letters of interest and resumes from a wide pool of applicants. The RFP's were received in December and the Executive Board is planning to hold interviews in January. I know the Executive Board joins me in wishing Richard and his wife Ann all the best as they begin a new chapter in their life and enjoy retirement!

Again, I wish all our members a very happy, healthy and prosperous 2016!

ON THE LIGHTER SIDE

Remarks by Mayor John Dean DeRienzo of Haworth on December 9, 1993 at the installation of officers of the Bergen County Municipal Clerks' Association held at White Beeches Golf and Country Club.

This is a very somber and "hysterical" occasion. In thinking about this I tried to envision what Municipal Clerks have in common. They are underpaid, overworked, taken for granted and nobody listens to them. In the Borough of Hayworth, as in the rest of Bergen County and on the planet Earth, there is a full moon, which shines 365 days of the year because every kook, weirdo and taxpayer attacks Borough Hall.

Clerks are not allowed to go to the bathroom during the day because they are too busy, they never go to lunch, they don't take sick days because that is a sign of weakness and they never go on vacation because the town would fall apart.

Family members, friends and loved ones are put into a situation where they learn certain things immediately: the day before a council meeting, the day of the council meeting and the day after the council meeting, don't ask for dinner. Secondly, if you ever make the mistake of calling Borough Hall on these days, you will usually get one of two answers: It makes no difference why you called, i.e., the house is burning down), "he or she is away from their desk or I can't talk to you right now, we're in a meeting."

Borough Clerks are faced with difficult problems—one their council members. Council Members are usually classified three ways: mild irritants, pains in the "arses", or should have a room at Bergen Pines. Mayors are considered to be egotistical maniacs to be tolerated by Borough Clerks.

I have wondered why Borough Clerks are the way they are. It's simple—it's your education, all the courses you take. You have to take tests and when you pass them, the end results are as follows: A. Every Borough Clerk knows more than the Borough Attorney because he knows nothing about the law.; B. Chief Financial Officers better pay attention because Borough Clerks know more about finance; C. Land Use ordinances and anything about planning and zoning—Borough Clerks know it all. There is really no need for a Borough Council or a Mayor, because you can run the entire show.

Now we get to the situation of how Borough Clerks treat Mayors and Council as people who just pass by, even though they are elected. First of all, they use intimidation. In our Borough office Mrs. Fay has over her desk a flag from the American revolution with a rattlesnake on it which says "Don't Tread On Me:. In addition to that, on her desk, which I brought to show you so you know I am not lying, is a nameplate which reads "A Woman's Place Is In Command".

Municipal Clerks are taught at an early age that Police Chiefs have no authority whatsoever. If a Police Chief brings anything in writing to a Borough Clerk, it is assumed automatically that policemen do not know how to read or write and certainly don't know grammar. What I've never been able to understand is how they're not afraid of policemen who carry guns—they pay no attention to them.

Mayors are usually relegated to one or two positions. In our particular town, Mrs. Fay is the ventriloquist and I am the dummy and I accept that. However, now and then the Rock of Gibraltar, the piece of the rock known as the Prudential, has a kink in the armor; nerves set in. I was shocked when I went to Borough Hall last week. Here was Mrs. Fay—she was down-trodden, saddened, shaking, quivering like a mass of jelly and there was even a tear in her eye. I made a mistake all Mayors make by asking, "What's wrong?". I thought that it was something really important like her husband Ed has suffered some major disease; it wasn't. It was because of all of you. She looked at me and said, "how can I be president of the Municipal Clerks' Association, how can I follow in the footsteps of the past presidents, how can I keep creative and innovative programs going for this organization, how can I find the best meeting places with gourmet food with the cheapest prices and will I be able to get the respect that I deserve, (notice, "I deserve"), from my peers?." That really touched a chord of sympathy; my initial reaction subconsciously was, I hope they chew you up and spit you out. Because that was totally unjust, I did not say that.

But I decided to find a way you would accept her. One, she deserves recognition. (Mayor reads proclamation). Now, that was the first thing to bolster her morale. Then I decided that obviously if I did not bring a gift I would no longer be the Mayor; she would get me. And, I don't want you to think that today is just an Ann E. Fay day. I have talked personally to the mayors of the other officers and asked them to write me a letter or send me a presentation and nobody responded.

So, I decided to get a gift you would instantaneously recognize so that you know when she assumes the mantle of leadership that she is prepared to do this. Ladies and gentlemen, I hope as Mrs. Fay opens the gift and shows you the gift that you will understand that this will help her in her new duties as President. (The gift is a baseball bat).

A fantastic 1994 season to all of you and don't mess with the new President.

OPRA SPECIAL SERVICES CHARGES, AND REFLECTIONS by Richard Lustgarten, MCANJ Legal Counsel

It has become quite common for OPRA requests to be overly burdensome and the fine line between searching for records and researching a request is often blurred. What has also become a major time consumer is the request that is voluminous in nature both as to the amount of documents requested and the time frame over which they were created.

OPRA provides a schedule for the cost of duplicating, usually 5 cents for letter size and 7 cents for legal size or larger. If a public agency can demonstrate that its actual costs are higher it may charge the higher amount provided it is reasonable. OPRA further provides that ".... if a request involves an extraordinary expenditure of time and effort to accommodate the request, the public agency may charge, in addition to the actual cost of duplicating the record, a special service charge that shall be reasonable and shall be based on the actual direct cost of providing the copy or copies...." (N.J.S.A. 47:1A-5.c)

Initially there was some confusion as to whether the public agency had to enact an ordinance to reflect the charges relating to this section. An ordinance setting forth specific charges in advance is, of course, counterintuitive to determining the actual cost relating to a specific request. The Law Division in 2002 so determined that the costs



relating to a specific request should be made on a case-by-case determination.

The GRC adopted this methodology and has indicated that an ordinance that reflects amounts for "extraordinary time and effort" is not only not required but runs counter to the statute.

Fortunately, the GRC has suggested a list of factors that a custodian should consider in calculating the cost of the "extraordinary" request. While it is significantly detailed, you may find other legitimate items to consider. (A full recitation of what the GRC has recommended can be found in its OPRA Alert released in Nov. 2009, Volume 2 Issue 2.) The following is a highlight of some of them.

- 1. The volume of government items requested.
- 2. The period of time over which the records were received or created.
- 3. Whether they are archived.
- 4. The amount of time taken to locate, retrieve and assemble the documents.
- 5. The amount of time, if any required by a public employee to monitor their inspection.
- 6. The amount of time required to "re-archive" them.

In a challenge before the GRC relating to an expense charge for the "extraordinary" request, the custodian will be required to provide the following information: What records are requested, a general description of the volume requested, the time period covering the records requested, whether or not they are archived, and the size of your work staff. Additionally, how many employees are available to accommodate the request, is redaction required, hourly rate and estimated number of hours required to monitor, fulfill and "re-archive" the request, why the particular level of employee was selected to fulfill the preceding tasks, and what is the availability of information technology and copying capabilities. Finally, an estimate of the hours needed to complete the request and the estimated cost of same.

Each of the above requirements will vary from municipality to municipality for the obvious reason. Also note that the requestor shall have the opportunity to review and object to the charge prior to it being incurred. This is problematic because some time and effort will be expended to determine the estimates involved, but this is the cost of fulfilling the obligations of OPRA and open government. The more detailed you can be, the better off you will be in defending the estimated cost to the requestor or to the GRC or Court if challenged.

I will have retired at the end of 2015 by the time you read this. It has been an honor and a pleasure to serve as counsel and advisor to your Association and to the many of you with whom I have personally interacted. While I conducted a general practice over the years in litigation, real estate, wills, business transactions, criminal defense etc., I devoted a significant amount of time representing public agencies as a prosecutor, municipal and planning board attorney, Boards of Health, and as a First Assistant County Counsel. I have also represented not only your association but other organizations as well. This list is not an attempt to create an epitaph (most prematurely I hope), but rather to give you some insight into my background as I make the following observations about government service in general and municipal clerks in particular. They are not recited in any order of importance.


I believe that most municipally elected officials run for office in an attempt to make things better in their community. Some run because they served on local boards or come from local organizations. Some see local government as a way to "step-up" to higher office. A few run to perpetuate (or commence) a political party. Most, in my view, are inadequately prepared for, or have no idea as to the complexities of local governing nor of the rigorous constraints of the local budget. Great campaign ideas fade rather quickly when faced with the reality of cost mandates or lack of a consensus on the Council. The worst, and fortunately they are few, wish to perpetuate the local campaign on every topic that comes up for consideration. It starts with the appointment of the "professionals" at reorganization and continues throughout the year. I have seen it become nastily personal and actually lead to blows. Fortunately, over time, these individuals don't get reelected when the public gets fed up with them. Most of you can identify with this type of elected official and I'm sure that the "good folks" on your Council far outnumber them.

Which comes to you. The Municipal Clerk has been statutorily created to be the official focal point of record keeping in the town along with the other mandated responsibilities by law. Unofficially, you are the "chief cook and

bottle washer" and the go-to person for historical memory and for the pulse of the community. (All due respect to managers and administrators-but the Clerk's office is the first line of public contact in non-criminal matters.) You are expected to know everything that's going on and perhaps venture an opinion about the members of the governing body. A wise clerk will not respond to the latter in any meaningful way.

You may be asked by the Mayor, or a Council member, to do some "secret" research for him/her and not share it with the rest of the members. Don't. You will be labeled as partisan or playing favorites if you do. Ask the governing body for the adoption of its policy as to when information is to be shared or not. Use common sense as well. You gotta live in the Municipal building. Decide if the elected officials want your input on policy or whether you are there solely in an administrative capacity. A wise Council will seek your input but not always as ego obstructs even the smartest of people. Take criticism from the public or the Council by considering the source but never let anyone attack your ethics or accuse you of criminality without your response being nuclear in nature (respectfully of course.)

Don't assume that the municipal attorney is overly proficient in municipal law. They are political appointments and may be new to the subject matter. A good attorney will work hand in hand with you. If he/she doesn't, try and guide them but don't wind up doing two jobs. (continued on page 23)



Below is a description of the various opportunities.

- 1. The <u>Constitution and Bylaws Committee</u> shall review and recommend to the Executive Board any amendments to the Constitution and Bylaws.
- 2. The <u>Education Committee & Professional Development</u>, in cooperation with Rutgers University, shall provide the educational opportunities required to achieve the certification and recertification as Registered Municipal Clerks. The Conference Committee, in conjunction with the Education Committee, shall prepare the education program for the Annual Education Conference. The committee also prepares and implements programs addressing the managerial and administrative skills necessary to meet the professional image of Municipal Clerks.
- 3. The <u>Education Conference(s) Committee</u> shall, in conjunction with the Executive Board, coordinate the programs and events at the Education Conference, or Conferences as the case may be, and shall contact the appropriate committees in such effort.
- 4. The <u>Elections Committee</u> shall examine and evaluate the statutory requirements governing elections as well as any proposed changes in election law and make appropriate recommendations to the Executive Board regarding same. (continued on the next page)

- 5. The <u>Fundraising Committee</u> shall plan and implement fundraising programs for the benefit of the MCANJ. The use of these funds will be used at the discretion of the Executive Board. By vote of the Executive Board, the MCANJ may advance funds to the Fundraising Committee for fundraising activities with reimbursement to the MCANJ Treasury from the fundraising proceeds, with primary consideration given to the Legal Defense Fund and the Scholarship Fund.
- 6. The <u>Information Technology Committee</u> shall provide and review information shown on the MCANJ Web Page and other Association authorized social media. In addition, the Information Technology Committee shall advise the Executive Board of other means of technology useful to the Municipal Clerk. This may include, but not be limited to, an Annual Information Technology Expo and/or assisting with soliciting persons versed in technolog-ical hardware, software, peripherals, and other technological devices useful to the Municipal Clerk for the Education Conferences.
- 7. The <u>Legislative Committee for Laws Pertaining to the Municipal Clerks' Profession</u> shall monitor and review all proposed legislation that may directly affect the Municipal Clerks' profession.
- 8. The Legal Defense Fund is available by private subscription of the membership for their benefit and is established for financial and legal assistance to its participating members. The <u>LDF Committee</u> shall solicit membership and through its own Constitution and Bylaws oversee the operation of said Fund. The financial records of said Fund are maintained by the Executive Director. The Executive Board shall hear appeals sent to it by the LDF pursuant to the LDF bylaws and the Executive Board shall establish rules and procedures for same.
- 9. The <u>Manual Review Committee</u> shall be charged with the annual review and publication of updates for the Municipal Clerks' Desk Reference Manual.
- 10. The <u>Membership/Peer Alliance for Learning Committee</u> shall be charged with the duty of securing and maintaining the enrollment of all Municipal Clerks, County Clerks and the Clerks of the Boards of Chosen Freeholders in the State of New Jersey. It may be designated further as Membership-North, Membership-Central and Membership-South, at the discretion of the President and shall be responsible for promoting a mentoring program between newly appointed Municipal Clerks and experienced\Registered Municipal Clerks to facilitate the training and education of new members.
- 11. The <u>Public Relations Committee</u> shall plan and organize the Booth at the Annual League of Municipalities Conference, as well as the information Booth at the Spring Education Conference. Additional duties include hospitality at all MCANJ events.
- 12. The <u>QUILL Committee</u>, the official newsletter of the MCANJ, which shall publish four (4) times each fiscal year,
- 13. The <u>Raffles Committee</u> shall conduct such appropriate events, as determined by the Executive Board. At the Transition Meeting of the each year, the Executive Board will determine where the proceeds from the raffles should be directed.
- 14. The <u>Records Committee</u> shall review pertinent decisions of the Government Records Council regarding the Municipal Clerk's responsibility in complying with the Open Public Records act and amendments and supplements subsequently enacted thereto, and report back to the Executive Board with their findings and recommendations on a regular basis. The Records Committee shall, in addition thereto, offer any practical recommendations to the Executive Board regarding problems that have been encountered or other foreseeable problems that may be expected in order for Municipal Clerks to comply with OPRA, as well as any pertinent issues dealing with records management. The Chairman of the Records Committee shall be the MCANJ representative to the Government Records Council.
- 15. The <u>Resolutions Committee</u> shall prepare and present at the Annual Meeting, resolutions recognizing those Municipal Clerks who have retired or passed away since the last Annual Meeting, as well as present any resolutions passed by the County Associations requiring action by the membership. It shall also present appropriate resolutions of recognition and service to Associations or individuals. Resolutions to be provided to the Secretary for inclusion in the minutes of the Annual Meeting.
- 16. The <u>Scholarship Committee</u> shall award financial assistance to deserving member Municipal Clerks and Deputy Municipal Clerks for courses required for certification and recertification as Registered Municipal Clerks.


