#### Women, It's Your Turn to Lead

Want to use what you know to drive change? Want to have a say in ongoing policy debates? Want to amplify the voices of women offering bold solutions when those issues are on the table? Then maybe you should run for office! As Washington DC veterans have been heard to say, "If you're not at the table, you're probably on the



menu." And at the tables where critical, life-altering decisions are made, women have often failed to secure choice locations.

Women who work in municipal government are experts at solving problems, creating innovative programs, managing complex organizations and communicating with the public. You see first-hand that local institutions have the most direct influence and impact on our daily lives. At the Center for American Women and Politics (CAWP), we know that women bring a different perspectives and experiences to their careers in public service - and that changes the way government works. We also know that when women run for political office, they win just as easily as men. The problem: Not enough women run for office. This dearth of women candidates means that far too many governing bodies lack the diversity of voices needed to represent all perspectives in our communities.

We enter 2017 with women stalled in their quest for public leadership. The bright side is that a record number of women continue to serve in Congress. The 115<sup>th</sup> Congress includes 104 women - a record 21 in the Senate (16D, 5R) and 83 in the House (62D, 21R). Women now comprise 19.4% of Congress. Nine new women of color, all Democrats, will enter Congress: three in the Senate and six in the House. A total of 38 women of color will serve in the 115th Congress.

# Message from President Denise Szabo



Happy New Year and Welcome to 2017!

Many of you are just coming off your reorganization meeting and it's the perfect time to provide your newly elected officials with a good foundation on how local government works. In this regard, MCANJ is again participating in the "New Elected Officials" Seminars sponsored by the NJ League of Municipalities on January 7 at the Hilton Meadowlands Hotel in East Rutherford, and on January 28 at the Hotel ML in Mount Laurel. Immediate Past President Keith Kazmark will present on January 7 and I will present on January 28. <u>CLICK HERE FOR MORE INFORMATION</u>.

Well, we did it! We survived another Presidential Election. The consensus of NJ Municipal Clerks is that most went well. A majority of municipalities were prepared for increased voter turnout but due to long lines at peak voting periods, there were some complaints, but by far the biggest complaint statewide seemed to be the lack of "I voted today" stickers. I found the NJ Division of Elections SVR Database to be very beneficial in answering questions real time. The ability for a voter to also secure their own log-in and password, to check their own

voting record and information was also a well received feature of the system.

Many of our members attended the New Jersey League of Municipalities Conference in Atlantic City during the month of November. The MCANJ sponsored sessions were well attended. Thank you to 1<sup>a</sup> Vice Pr esident Dina Zawadski and Education Chairperson Joanne Kwasniewksi for planning the sessions, as well as Executive Director Joel Popkin, Public Relations Chairperson Alberto Cabrera, and our members and retirees who helped out at our MCANJ booth.

The International Institute of Municipal Clerks (IIMC) Annual Conference will be held from May 21 to May 24, in Montreal, Quebec, Canada. With our own Vinny Buttiglieri serving as IIMC president, the conference is sure to be a good one. For NJ IIMC members who are contemplating attending, we are considering sharing the cost of a charter bus to and from the conference. As many of you know, MCANJ Attorney Steve Goodell, an avid bicyclist, had a serious biking accident on October 15 when he was out for his usual group training ride. There was no automobile involved but a bunch of cyclist went down and Steve landed badly and suffered a severe spinal injury. Steve was in the hospital for several weeks, followed-up by intensive physical therapy. Steve continues to make progress and MCANJ wishes him well as he recovers. During this period, Steve's colleague, Michael Herbert, Esq., has been representing MCANJ. January is also midway through MCANJ's fiscal year and we are making good progress on several fronts.

Desk Reference Update: Deanna Bennett, Chairperson of our Manual Review Committee, along with a small subcommittee made up of Laura Flagg of Rutgers, Sharon Young the Chairperson of our Records Committee, Kim-Marie White the Chairperson of our Legislative Committee, and Steve Goodfellow our consultant from Access Systems have completely revamped the Records section of our Desk Reference Manual to bring it in line with the 21<sup>a</sup> Century Municipal Clerk responsibilities as Records Custodian. The anticipated launch is the summer of 2017. Laura will now consult with the current course instructors to obtain their perspective on the chapter's delivery and roll out, including potentially adding a computer lab to the course and updating the new chapter into an online format. Laura will also work with Shannon Hudak of the DCA for updating the state exam. A big thank to members of the committee and instructors for their assistance in this project.

Elections Webinar – SVRS: Over 290 members registered for the first ever MCANJ sponsored webinar on October 5. Unfortunately, there was a technical glitch with the host's third party software and not all members who registered were able to get into the virtual conference room. The Division of Elections and Everyone Counts worked quickly to reschedule a repeat Webinar for October 7. Even with the technical glitch, the feedback was excellent. MCANJ members were able to secure a full 2 CEUs in Elections at no cost and without leaving the comfort of their office. Thank you to Director Robert Giles from the NJ Division of Elections and Brittany Giampola from Everything Counts for partnering with MCANJ on this webinar. In am in discussions now with the Census Bureau about providing a webinar to the membership in the Spring.

S-1046 (OPRA) and S-1045 (OPMA) - Senator Weinberg's office contacted me to set-up a meeting to discuss proposed changes to OPRA and OPMA. I appreciate the Senator's courtesies of reaching out to MCANJ regarding changes to legislation. As of this writing, the meeting is scheduled for December 16. At the NJLM Conference this year a resolution was adopted calling for a study on the cost and application of OPRA. This is the fifth resolution since 2008 that the NJLM has adopted calling for OPRA reform. I will certainly keep the membership informed on any new developments.

A-4006 (Common Sense Shared Services) – This bill, sponsored by Assemblywoman Joann Downey, was recently introduced. This bill adds Monmouth County to the existing legislation as a pilot county. MCANJ opposed the original Common Sense Shared Services legislation when it was adopted because it erodes tenure and removes the impartial nature of the Municipal Clerk's position. There are other issues that we raised, including potential conflicts of interest of a Municipal Clerk serving two Municipalities, and potential conflicts concerning the faithful performance of Election duties, attendance at Council meetings, timely compliance with the Open Public Records Act (OPRA), and other concerns. We will continue to monitor this legislation.

Article VI Section 1.1. of the current Constitution and Bylaws of the Municipal Clerks' Association of New Jersey, Inc., specifies, "Any individual seeking to be a candidate for Secretary must file with the Secretary not later than January 15th of the current year of the Annual Business Meeting. This position shall serve from July 1, 2017 through June 30, 2018.

## **OPRA & Security Cameras**

The Clerks Association wishes a quick recovery to our good friend and Counsel, Steven Goodell, Esq. Thank you to Michael Herbert, Esq. for stepping in and contributing in his temporary absence.

In a recent decision by the New Jersey Supreme Court, a ruling was made that footage from security camera mounted in the public area is not subject to release to citizens pursuant to *N.J.S.A.* §47:1A-1 to 47:1A-13 also known as the Open Public Records Act ("OPRA").

The Supreme Court reversed the Appellate Division decision that the Township of Bloomfield had improperly denied access to a well-known OPRA activist/resident who sought video from a camera mounted outside the Municipal Building pursuant to OPRA. The Court in a 4 to 2 decision decided that this type of footage could still be requested under the State's Common Law Right of Access which is an older law that requires a tougher balancing test for the potential harm of releasing records against the public's right-to-know.

The litigation began when Ms. Gilleran made the request pursuant to her own citizen investigation of possible misuse of municipal parking spaces by local officials. Her request was denied under OPRA's security exclusions. The municipality asserted that releasing the footage would create a security risk by disclosing the surveillance camera's capabilities and because Township Hall was next to a police station jeopardizing the safety of crime victims, witnesses, and confidential informants coming and going from the building. Ms. Gilleran argued to the Court that the camera was mounted in plain sight and captured a video of a public area and that the public should have a right to review its footage.

The Law Division Judge ordered the release of the footage under OPRA and the Appellate Division upheld the ruling. The Supreme Court, through Judge Jaynee LaVecchia ruled that the release of the video would undermine the security purposes of the camera. She continued that once OPRA is interpreted to require unfettered access to the work product of any camera as part of a governmental facilities' security system, the footage from such cameras, whether they be located in police stations, courthouses or correctional institutions, would be subject to release on demand.

The Justice went on to state that the case was better analyzed under the Common Law Right-of-Access where the asserted need for access can be weighed against the need for governmental confidentiality.

Justice Stuart Rabner dissented in the case and stated that common law was not a substitute for OPRA because it shifts the burden to the requester to demonstrate the need for access rather than relying on the government to prove that a record is exempt.

The news for women serving in state legislatures is decidedly less optimistic. After all new legislators take their seats in January 2017, 24.8% of state legislators around the country will be women, a proportion that has not changed significantly over the past decade. New Jersey will rank 13<sup>th</sup> in the nation for the proportion of women serving in the state legislature. At the local level, at the end of 2016, women were 262 of the 1,393 mayors of US cities with populations of 30,000 and above (18.8%,). In New Jersey, no women served as county executives; women comprised 26.4% (36 of 137) of county freeholders, 36.9% (24 of 65) of county constitutional officers, and 14.5% (82 of 565) of mayors.

So why is change so slow? Among other things, the number of women candidates is not increasing at a pace necessary to see gains The flat line in women's representation is consistent with the flat line in women's candidacies, serving as yet another reminder of the need to encourage, support, and mobilize women to run.

Electing more women could be in itself a way to attack tough problems. That's why we seek talented women to take up the challenge. Often we hear that women are waiting for an invitation to run for office. Consider yourself invited, and consider a candidacy today. Your perspective could influence the direction of important policies for years to come. It's the best gift you could give to yourself, your family, and your community. **Consider this your invitation to take the next step by attending Ready to Run**<sup>®</sup>!

**Ready to Run**<sup>°</sup>, CAWP's annual bipartisan two-day campaign training program, demystifies the process of running for elected office and introduces participants to elected and appointed leaders, campaign consultants, and party officials. This year's Ready to Run<sup>°</sup> is scheduled for March 10-11 at the Douglass Student Center, Rutgers-New Brunswick.
