The CMC program is designed to enhance the job performance of the Clerk in small and large municipalities. To earn the CMC designation, a Municipal Clerk must attend extensive education programs. The CMC designation also requires pertinent experience in a municipality. The CMC program prepares the applicants to meet the challenges of the complex role of the Municipal Clerk by providing them with quality education in partnership with institutions of higher learning, as well as State / Provincial / National Associations. The CMC program has been assisting clerks to excel since 1970.

### Master Municipal Clerk (MMC) Program

The MMC program is one of the two professional designations granted by IIMC. The MMC program is an advanced continuing education program that prepares participants to perform complex municipal duties. The program has an extensive and rigorous educational component and a professional and social contribution component. The MMC applicant must demonstrate that they have actively pursued education and professional activities.

- Board Awards Its 2024 Annual Conference to Calgary, Alberta, Canada
- Board Selects The Netherlands to Host 2021 Study Abroad/Symposium Programs
- Approved the 2019 year-end projected budget and the proposed 2020 budget. Both budgets are balanced with a Board Designated Reserve fund of approximately \$810,000
- Voted to add a fifth day to the 2021 Annual Conference in Grand Rapids, MI, to commemorate IIMC's 75th anniversary
- Approved a new three-year contract for its Executive Director
- Conducted its annual evaluation of the Executive Director
- Approved continuing with the findings of the Education Task Force, with a final report to be delivered in May 2020
- Approved to remove from its Constitution the requirement for written support by a member from his or her state/provincial/
  national association to become a candidate for Region Director. The Board believed removing this prerequisite will generate a
  more inclusive interest in running for a vacant Board position. The amendment to the Constitution will require a membership
  vote in May 2020

This article is being written in mid-December so a belated Happy Holidays to all. In researching topics to write about I try to emphasize recent cases or trends in the law that would be of interest to you. In southern Indiana you can't get a good bagel, crisp Italian bread or tasty thin crust pizza. I once went in to a fast food place for coffee and asked for a buttered roll which was met with a quizzical look. No buttered rolls but I could get a biscuit, and if I through caution to the wind, a biscuit with gravy. They put it in a sack not a bag. The local joke when asking about your background is to say "Hoosier your Daddy." (Look it up.) It took a while to understand that "You're fahn" is a way of saying everything's ok. There is some lingering of "No problem" but it is not the favored expression. If they make a comment about New Jersey my retort joke is "What do you call road kill in these parts" and the correct response is "dinner."

Before you get the impression that this is a wasteland, I need to point out that there is an abundance of Burger Kings. Arby's, Taco Bells and of course, McDonalds, so we are not really far removed from civilization. In fairness, I should point out that there is also Panera, Outback, Ruth's Chris, Morton's Steak House, Olive Garden etc. In Louisville there are Broadway quality shows and Broadway touring companies along with an active Actors Studio for innovative plays along with museums, the Louisville Slugger factory which manufactures professional and amateur baseball bats, and of course distilleries. Churchill Downs race track is twenty minutes away.

One thing I learned dramatically is that there is a great divide between "red" and "blue" supporters. Discussions get quite lively and I consciously try to avoid them. No, I'm not talking politics. Out here basketball is king, and both the Louisville Cardinals (red) and the Kentucky Wildcats (blue) have ardent fans. When we were building our home my wife asked the kitchen contractor to consider a blue back splash. He said he was a "Louisville lifer" and if we insisted on blue he wouldn't finish the job. To this day I don't know if he was serious. (We settled on a more neutral color.)

Living out here has also given me a different perspective on guns. New Jersey has some of the most restrictive laws relating to possession and carry licenses. Out here it is no surprise that someone owns a gun and many have possessed them since child-hood. It's not too far-fetched to say that owning a gun is like owning a bicycle or a toaster. It's not just law enforcement or "bad guys" that have guns but rather most anybody who wants one (with the obvious exceptions of felons, domestic violence abusers, mentally impaired, etc.). Its just no big deal. While I haven't encountered fanatic "Second Amendment" advocates, the gun owners I do know are "just plain folks" who expect gun ownership to be a personal choice and a way of life if that's the choice they make.

I follow local government issues and some court cases and they are basically the same as back in NJ. The same discussions over budgets and congestive zoning hit the news with the same regularity that you see in your local papers. Because I still consider myself a Jersey Boy I also get the digital version of the Bergen Record everyday. Sadly, I see some of the same controversies that linger on for years or recognize past associates or adversaries. As it is said, some things never change.

For now, I'm not one of those individuals who has so much to do in retirement that "I don't know how I ever got anything done when I was working" nor someone who has so much time on his hands that counting tree leaves becomes an occupation. When some of the other retirees in our complex (no. we're not a retirement community) grouse that the grass wasn't cut to the height in the specs or something equally as vacuous in my view, I just roll my eyes and contemplate my next tee time. For those of you contemplating retirement, balance is the key. I am sure you will find your own niche. And when someone says, "Gee, I hate to do this to you but...." you can easily turn to them and say "Then don't".


