SPOTLIGHT ON: CUMBERLAND COUNTY 21 stories of our Garden State; 21 stories to say "We're Great!" Located in the heart of the Northeast corridor of the USA, Cumberland County is situated along the Delaware Bay and conveniently located two hours from New York City and Baltimore, forty five minutes from Philadelphia and Atlantic City. Cumberland County was founded in January 1748 and occupies over 500 square miles of land in the south central part of New Jersey with over 40 miles of Delaware Bay coastline. According to 2006 estimates from the U.S. Census Bureau over 154,000 people call Cumberland County home. It is comprised of 3 Cities, 10 Townships and 1 Borough. Cumberland County's economy was developed around four principal indus-Brown's River Ad tries: glass making, food processing, textiles and maritime trades. As early as the 19th century, NJ was one of the 4 leading oyster producing States in the Nation. Port Norris became known as the "Oyster Capital of the World". It was said that there were more millionaires per square mile in the Port Norris area than anywhere else in the Nation. By the late 1800's there were over 300 oyster boats operating on the Delaware Bay employing approximately 1500 people. The Glass industry also had a significant presence in all three cities until the 1970's. Today, Cumberland County enjoys a strong agricultural base with targeted industries that include Health Care, Construction, Hospitality/Tourism and Advanced Manufacturing. Rice Notices: Who gets them

Under the Open Public Meetings Act <u>N.J.S.A.</u> 10:4-6 et seq. (OPMA), there are circumstances in which it is appropriate to exclude the public from discussions. One in particular is <u>N.J.S.A.</u> 10:4-12(b)8 which provides:

(8) Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of, promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.

The case of <u>Rice v. Union County Regional High School Bd. of Ed.</u>, 155 NJ Super. 64 (AD 1977) cert. denied 76 N.J. 238, (1977) resulted in the requirement of <u>Rice</u> notices. The <u>Rice</u> case addressed circumstances involving employees. There the court held that notice must be served upon the employee if the public body's intent is to discuss the employee. The employee would then have the opportunity to decide whether he wants the meeting to be in public, instead of a closed Executive Session. The exact language the court used was "The request for a public hearing is a personal decision on whether <u>the individual</u> desires his or her private personnel matters to be discussed in public." (emphasis added)

Another case which interprets <u>N.J.S.A.</u> 10:4-12(b)8 is <u>Jamison v Morris School</u> <u>Dist. Bd. of Educ.</u> 198 N.J. Super. 411, (App. Div. 1985). In <u>Jamison v. Morris Sch. Dist. Bd. Of Educ.</u> 198 N.J. Super. 411, 416 (App. Div. 1985). The Court said, at 415, "<u>N.J.S.A.</u> 10:4-12(b)(8) vouchsafes two <u>rights</u> to a public employee who may be adversely affected by a personnel action or decision of his employer which are:

(1) a right to privacy that is to a non public discussion at a closed meeting; and (2) a right to a public discussion at an open meeting upon his request in writing."

A question arises as to whether a <u>Rice</u> notice is required for personnel actions not involving employees, but appointees. What is clear is that while Rice addresses employee circumstances, it does not limit its applicability to employees. The Supreme Court in <u>South Jersey Pub. Co. Inc. v. New Jersey Expressing</u> <u>Authority</u>, 124 N.J. 478 (1991) held that exceptions under OPMA are to be

Circumstances in which the issuance of a <u>Rice</u> notice may apply are those in which there is a discussion of an actual or anticipated personnel action

strictly construed. <u>Accardi v. Mayor and Council of City of North Wildwood</u>, 145 NJ Super 532 (L. 1976) held that the exceptions to OPMA are to be strictly construed so that the stated broad public policy can be achieved of openness and disclosure at meetings of public bodies. With these cases in mind, it is clear that we must strictly construe the exceptions. Accordingly, the strict meaning of the exception is not limited to employees only.

At this particular point, many of you are reading this article with wide eyes and disbelief as to the implications of the analysis set forth herein. Let me temper the analysis in this article by the implications of practical reality and the law pertaining to OPMA. First, as a matter of practical implication, the exclusion under OPMA is regarding discussions, not actions. The act of appointing and/or confirming an appointment is never done in closed session. Acts are always done in open session. If the appointing authority simply makes an appointment and confirms it without discussion, a <u>Rice</u> notice may not be required. Even if one were required, if there was only one appointee for a particular position, the only person who would have standing to bring suit for an alleged violation of OPMA under the personnel exemption would be the appointee. Clearly, the appointee would not bring suit challenging his/her own appointment as being voidable. Additionally, an allegation of a violation must be brought within 45 days of the act sought to be challenged. An action in lieu of prerogative writs would need to be filed and even in such an event, the action is not deemed "void", but "voidable'.

Circumstances in which the issuance of a <u>Rice</u> notice may apply are those in which there is a discussion of an actual or anticipated personnel action, as is more fully set forth in the personnel exemption. If a public officer and/or employee (neither of which terms are defined by OPMA) have a right to be notified and an opportunity to be heard, clearly a <u>Rice</u> notice is required. For example, if "Public Officer X" is a term-appointed officer and the governing body wishes to remove that officer during the term, clearly the governing body would need to provide a Rice notice because the employee would have a reasonable expectation that he/she may continue in the office during the term, unless there is a specific reservation that the officer serves at the pleasure of the appointing authority.

While OPMA does not define "public officer" and/or "public employee", the New Jersey Local Government Ethics Law is instructive as to the definition of a local government employee and/or local government officer. <u>N.J.S.A</u>. 40A:9-22.3 (f) & (g) provide as follows:

- f. "Local government employee" means any person, whether compensated or not, whether part-time or full-time, employed by or serving on a local government agency who is not a local government officer, but shall not mean any employee of a school district;
- g. "Local government officer" means any person whether compensated or not, whether part-time or full-time: (1) elected to any office of a local government agency; (2) serving on a local government agency which has the authority to enact ordinances, approve development applications or grant zoning variances; (3) who is a member of an independent municipal, county or regional authority; or (4) who is a managerial executive or confidential employee of a local government agency, as defined in section 3 of the "New Jersey Employer-Employee Relations Act," P.L.1941, c.100 (C.34:13A-3), but shall not mean any employee of a school district or member of a school board; (emphasis added)



It is my opinion that a court may very well use these definitions as an expression of the state of the law of the State of New Jersey with regard to municipalities. Obviously, any OPMA issue and/or personnel issue in a public body context should be referred to the counsel for the public body on a case by case basis. Each public body has a comfort level with the potential for litigation and the implications associated with their actions. In the end, each public body must use its best judgment and, in good faith, endeavor to follow the spirit and intent of the law.
