We tried some new things at this conference which worked very well, including a session on Monday afternoon, and using scanning technology, courtesy of United Computer, for attendance at the sessions. I know that those of you who heard Dr. Susan Dellinger

speaking about "Psycho-Geometrics" and U.S. State Attorney Christopher Christie speak about the work he and his staff are doing to clean up political corruption in New Jersey, were inspired by their messages. Thanks to those of you who purchased clothing or bid on items at the silent auction during the conference, we were able to raise the most money that we ever have, which will be put towards scholarships.

I was proud to represent the State of New Jersey at the annual International Institute of Municipal Clerks' conference which was held in Atlanta, in May. Carrying the New Jersey flag in the Opening Ceremony was a highlight. In addition, I was able to meet with other State Presidents to share mutual items of interest and concern. During the IIMC Conference, Allan Susen, the Municipal Clerk from Haledon, stepped down as Region II Director, and Jane Williams-Warren, the Municipal Clerk from Paterson, was sworn in as Region II Director. An important development that came out of the IIMC conference was new guidelines for the Certified Municipal Clerk (CMC) and Master Municipal Clerk (MMC) certifications. 
Sussex County Has Been Active in Transitions!

SPOTLIGHT ON: WARREN COUNTY

21 Stories of Our Garden State; 21 Stories to say "We're Great"

Located in northwestern New Jersey, Warren County is home to more than 110,000 residents, with a rich history and beautiful scenery. Warren County came into existence in 1825 when an act of the New Jersey Legislature separated the area from Sussex County. The county was named in honor of Dr. Joseph Warren who earned a heroic reputation throughout the original 13 states for his devotion to the revolutionary cause, which led to his death in the battle of Bunker Hill. During the Revolutionary War, a large majority of the 13,000 colonists who lived in Sussex (and what is now Warren) supported the patriotic cause.

Transportation has played an important role in the development of the county since its beginning. Its earliest residents were the Lenni Lenape, who lived along the rivers and streams of the region. The first Europeans to settle in the county were the Dutch, who came to Pahaquarry Township and dug for copper around 1650. During this period, they constructed a road from Pahaquarry to Kingston, N.Y., over which they transported the proceeds of their mining ventures. This road, the first commercial highway built in the United States, is still in existence today. Known as "Old Mine Road," it traverses the Delaware Water Gap National Recreation Area, a major visitor attraction in the county.

Although it was the first area to be settled by European colonists, Pahaquarry Township is no more. Largely vacated by the federal government's disputed plan to build the Tocks Island Dam, much of Pahaquarry later became federal and state parkland. With only a handful of residents left, the Township merged with neighboring Hardwick Township on July 2, 1997, reducing the number of municipalities in New Jersey to 566. Accomplished through special legislation, the merger was the first one in the state in 45 years.

In the early 1830s, the Morris Canal opened in New Jersey, with its western terminus at Phillipsburg on the Delaware River in Warren County.

The Morris Canal brought together the anthracite coal from Pennsylvania with the limestone and iron ore from New Jersey in the formation of heavy industry. Railroads quickly replaced the canal and sped the development of industry within the county.

At one time, Phillipsburg was the crossroads for five railroads, each with its own freight yard and maintenance facility in the town. Also, one heavy manufacturing plant employed up to 4,500 people and provided a great deal of machinery to the World War II effort. At Oxford are the preserved ruins of one of colonial New Jersey's first iron furnaces, and it holds the distinction of operating longer than any other colonial furnace, from 1741-1884. In 1835, Oxford Furnace became the first U.S. smelting operation to use the hot blast process, while in 1859 Peter Cooper's furnace in Phillipsburg was one of the first in the U.S. to experiment with the Bessemer process. During the 1860s, Cooper Furnace was the most productive iron furnace in America.

Today, sections of the Morris Canal are being transformed into a public greenway across the county. Moreover, because of its transportation prominence, Phillipsburg has been tapped as the location for a planned New Jersey Transportation Heritage Center, a museum to highlight how New Jersey shaped transportation history and how transportation shaped the state.

The Unique Nature of Municipal Land Use Ordinances

All Municipal Clerks should be aware of the difference between a resolution and an ordinance as well as specific introduction, adoption and publication requirements of an ordinance. What gets tricky is when an ordinance is identified as a municipal land use (MLU) ordinance. Oddly enough, some municipalities even include ordinances which are not readily identifiable as relating to the issue of MLU in the zoning/land use section of the ordinance. The most cautious counsel I can offer is to begin by identifying the chapter of the ordinance which addresses “Zoning” and or “Land Use” and keep a mental note in the back of your mind that ordinances appearing on your agenda which are either adoptions of new ordinances or amendments of existing ordinances relating to these topics need to be addressed in a unique fashion in order to become effective. When in doubt, Call your attorney and ask for a legal call as to the classification of the proposed ordinance.

Both resolutions and ordinances are required to be reduced to writing, but under N.J.S.A. 40:49-1, an ordinance must be read at more than one meeting thereof and published. The specific procedures set forth in N.J.S.A. 40:49-2 are too extensive to replicate herein, however in addition to the specific procedures identified therein, a MLU ordinance must also comply with the Municipal Land Use Law, N.J.S.A. 40:55D-1 et seq.

Under N.J.S.A. 40:55D-62, the adoption and/or amendment of a MLU ordinance in the form of a zoning ordinance cannot become effective upon initiative and/or referendum. Nonbinding voter participation is permitted, per the NJ Supreme Court in the case of Great Atlantic v Point Pleasant, 137 N.J. 136 (1994), but binding measures are prohibited. Under N.J.S.A. 40:55D-62a, a zoning ordinance must be referred to the Planning Board and only after the Planning Board has adopted the land use and housing element aspects of the Master Plan (which is generally, the document which identifies the land uses, development proposals, maps, recommendations, objectives, principles, assumptions, policies and standards for the physical, economic and social development of the municipality with due consideration to population density and development intensity density).

Further, under N.J.S.A. 40:55D-62, the adoption and or amendment of a MLU ordinance “relating to the nature and extent of the uses of land and of buildings and structures thereon” must be referred to the Planning Board for a period of 35 days after first reading. Under N.J.S.A. 40:55D-26, the Planning Board must report to the Governing Body “as to identification of any provisions in the proposed development regulation, revision or amendment which are inconsistent with the master plan and recommendations concerning these inconsistencies and any other matters as the board deems appropriate”. No hearing by the Planning Board is necessary under the statute, but any deliberations must occur in compliance with the OPMA. The Governing Body may disapprove or change any recommendation by a vote of a majority of its full authorized membership and shall record in its minutes the reasons for not following such recommendation. If the Planning Board fails to report back within 35 days, the ordinance can be formally adopted without comment from the Planning Board.

Municipal Clerks must be mindful of the notice provisions of N.J.S.A. 40:55D-62.1. Where an amendment to the zoning ordinance proposes a “change to the classification or boundaries of a zoning district, exclusive of classification or boundary changes recommended in a periodic general reexamination of the master plan by the Planning Board pursuant to N.J.S.A. 40:55D-89”, notice must be served at least 10 days prior to the hearing by the Municipal Clerk. Owners of all real property (as shown on the current tax duplicates) are required to receive notice. Owners located in the district in which there is a classification change, within 200 feet in all directions of the boundaries of the district (within the State of NJ) In the case of a boundary change, within 200 feet in all directions of the proposed new boundaries of the district which is the subject of the hearing (within the State of NJ).

Additionally, notice must be provided to any military facility commander who has registered with the municipality pursuant N.J.S.A. 40:55D-12.4, if the military facility is “situated within the district or within 3,000 feet of all directions of the boundaries of the district or located, in the case of a boundary change, in the State within 3,000 feet in all directions of the proposed new boundaries of the district which is the subject of the hearing.”

Pursuant to N.J.S.A. 40:55D-62.1, the governing body’s hearing notice must state:

- a. the date, time and place of the hearing,
- b. the nature of the matter to be considered and
- c. an identification of the affected zoning districts and proposed boundary changes, if any, by street names, common names or other identifiable landmarks, and by reference to lot and block numbers as shown on the current tax duplicate in the municipal tax assessor's office.

Notice is effectuated by:

- (1) serving a copy thereof on the property owner as shown on the said current tax duplicate, or his agent in charge of the property, or
- (2) mailing a copy thereof by certified mail and regular mail to the property owner at his address as shown in the said current tax duplicate. (In the case of an applicable military facility as identified above, notice is properly effectuated by personally serving a copy on the military facility commander who has registered with the municipality pursuant to N.J.S.A.40:55D-12.4 or by mailing a copy by certified mail to the military facility commander at the address shown on the registration form.

The statute requires the Municipal Clerk to execute affidavits of proof of service of the required notices and keep the affidavits on file along with the proof of publication of the notice of the required public hearing on the proposed zoning ordinance change.

The import of these requirements is very simple; if they are not followed, the ordinance is invalid and ineffectual. Under N.J.S.A. 40:55D-16, "Development regulations, except for the official map, shall not take effect until a copy thereof shall be filed with the county Planning Board. A zoning ordinance or amendment or revision thereto which in whole or in part is inconsistent with or not designed to effectuate the land use plan element of the master plan shall not take effect until a copy of the resolution required (by N.J.S.A. 40:55D-62(a)) shall be filed with the county Planning Board."

Remember, use your common sense and reasoning when addressing the adoption or amendment to an ordinance which seems to relate to the nature and extent of the uses of land and of buildings and structures. Sometimes knowing when to ask a question is half way to the destination of wisdom. If the ordinance relates to land or structures or even the procedures involved relating to land or structures, a red flag should go up in your mind. Unless it is clearly part of the zoning ordinance and or land use ordinance, refer the matter to your municipal attorney to opine in writing as to whether the ordinance is subject to the provisions of N.J.S.A. 40:55D-62 based upon the case law and nature of the ordinance.



In 1662 James was brought to England and installed at court as a favorite of the king, who on Feb. 14, 1663, named him Duke of Monmouth, Earl of Doncaster. The Duke had many friends and allies among the gentry of East Jersey. But we may never know for sure how Monmouth County got its name.

Freeholder Director Lillian G. Burry says, “When it comes to studying our nation’s history, the people of Monmouth County do not have to rely on our history books alone. The history of this great nation is all around us, because Monmouth County was an important part of it. During the Revolutionary War, the Battle of Monmouth Courthouse was a turning point for the Continental Army led by General George Washington. There are many other local historic events as well. It is my pleasure to invite each of you to reflect on Monmouth County’s rich history as we celebrate our 325th anniversary.”

The Monmouth County seal was authorized by the freeholders as indicated by the following excerpt from the minutes of the Board of Chosen Freeholders, on May 9, 1798: “Ordered By Said Board that Jacob Holms get a Seal made the Sise to be the Bigness of half a Dollar & The Device to be the Plough and the letters Monmouth on The face.” The use of the image of a plough on official seals was quite common in 18th Century New Jersey. Ploughs can be found on the Surrogate’s Seal, the Great Seal of the State of New Jersey and various coins minted in early America.
