### MEMOS YOU WILL NEVER RECEIVE AND EVENTS THAT WILL NOT HAPPEN

After a pretty tumultuous year I thought a lighter view of possible events might be in order. So, have you ever felt that you were in a parallel universe but you were parked diagonally? If so, come along for the ride.

Court decides that the "no smoking in public buildings" ban does not apply to weed as that has now been legally approved for use.

League of Municipalities adopts resolution that recommends municipal employees should work a four day week, five hours a day.

To avoid disruption of services, all municipal unions and governing bodies agree that contracts should be for a term of ten years.

With new high end technology, voting is authorized to be by phone, directly into the voting machine. If a voter doesn't have a phone, he/she can borrow a friend's and vote that way.

In the spirit of cooperation, counties return fifteen percent of their revenues to any municipality that asks for it. If they don't ask, they get five percent.

In a further spirit of cooperation, eighty percent of municipalities agree to merge provided they can keep all their employees, elected officials and administrative boards. State still predicts massive savings over thirty years.

The Legislature in the spirit of transparency agrees that OPRA applies to the Senate and Assembly. Governor breathes sigh of relief.

For two years running no municipality has received a complaint concerning leaf and snow removal and garbage pick up.

All Democrats and Republicans agree to run on joint tickets to reduce cost of campaigns and elections. This agreement has a sunset provision of one election cycle.

Statute authorizes all citizen complaints to be outsourced overseas. Must be heard within one year.

To save money all departments must surrender their landlines as only cell phone use is permitted. If department doesn't have a cell phone, notice of same shall be published in local paper once each January.

To assure quality services, all professional fees shall equal or exceed those charged on average in NYC and Philadelphia. Municipal attorneys, engineers and auditors only reluctantly agree because they believe their current fees and services are above average.

Department of Law issues an opinion that municipal clerks can veto and remove any agenda item that they deem "stupid". DOL estimates a reduction of agenda items by 65%.

As it is desirable to have contract bidders familiar with town matters, no bid contracts may be awarded to relatives of Mayors and Councilmembers as they are best situated to know what's going on.

If the time for public comment continues too long, the Council shall provide another room for the residents to talk among themselves while the Council stays in meeting room and proceeds with its meeting.

The Legislature, in a unique experiment, disbands all local elected officials. CLERKS RULE.

The IIMC Conference Statement is;


### NEWLY APPOINTED MUNICIPAL CLERKS

### **MCANJ News & Updates**

### Daniel's Law Update:

On November 20, 2020, Governor Murphy signed Daniel's Law that amends the Open Public Records Act ("OPRA") to exclude from the definition of a public record the portion of any document which discloses the home address of any active or retired 1) judge, 2) prosecutor or 3) law enforcement officer. The law is named after U.S. District Judge Esther Salas' 20-year-old son, Daniel Anderl, who was fatally shot in July 2020 by an assailant who obtained the family's North Brunswick address online.

Daniel's Law also prohibits state or local government agencies, individuals and businesses from knowingly publishing on the internet, or otherwise making available, the home address or unpublished home telephone number of any active or retired judge or any active or retired prosecutor. Other than governmental agencies, a violation requires the posting be made "with purpose to expose another to harassment or risk of harm to life or property, or in reckless disregard of the probability of such exposure." Anyone violating its terms faces a third-degree crime punishable by three to five years in prison and a fine of \$15,000, or both.

The bill enables any active or retired judge, prosecutor, or law enforcement officer whose home address or unpublished telephone number is disclosed on the internet or otherwise made available to the public, or whose immediate family member's name, home address, or unpublished phone number is disclosed on the internet or otherwise made available to the public, to request that the information be removed. The government agency, individual or business would be required to remove the information within 72 hours of receiving such a request in writing.

In late February 2021, Governor Murphy signed S-3453/A-5359 to amend Daniel's Law "with certain provisions and effective date applicable to disclosure of personal information of judicial officers, prosecutors, and law enforcement officers." As noted in the amendment Bill statement, "[t]his bill changes to December 10, 2021 the effective date of certain provisions of P.L.2020, c.125, known as 'Daniel's Law,' applicable to any active, formerly active, or retired judicial officer or prosecutor...The provisions applicable to law enforcement officers take effect 18 months after the effective date applicable to the provisions governing judges and prosecutors." However, the amendment does not change the effective date of the section of law permitting any active, formerly active, or retired judicial officer or prosecutor, formerly active, or retired judicial officer or prosecutor, business, or association to request removal or redaction of that information. The request must be honored within 72 hours.
