## TIMELESS ADVICE

As we prepare for another League of Municipalities Convention, the following article may lend a sense of perspective:

#### "PENNY WISE AND POUND FOOLISH

We read a lot these days of taxpayer group criticism of what they term 'junkets' by municipal officials, and one of their targets is attendance at the Annual Conference of the League of Municipalities and affiliated associations at Atlantic City. If some of these loud voiced critics would take the time and trouble to attend these conferences and see for themselves that mighty few of the thousands of municipal officials in attendance do any 'junketing' they might realize that their officials take their responsibilities seriously and are earnestly trying to learn how to serve their municipalities more effectively. Unfortunately some governing bodies take this criticism too seriously and think they can save some tax money by not attending the annual conference. This is a 'penny wise and pound foolish' concept of economy, for just a few of the ideas gained more than pay for the comparatively slight expenditure of municipal funds. Of course this is assuming the officials do not go overboard in their expense accounts and expect to recoup their entertainment expenses out of the public treasury. Many times the information gained from discussing mutual problems of administration with fellow officials results in an ultimate saving of municipal funds by learning better ways of handling the endless strains on the municipal economy. There is no better way to learn how to cope with these problems than by talking them over with other officials who have had to find the most economical solution. The Annual League Conference is the best place to find these answers. Every governing body expects its engineer, attorney, and other professional consultants to keep up to the minute in their fields through their professional associations and there is no good reason why they should not apply the same reasoning to their own community responsibility. In these days of skyrocketing budgets no municipal official can afford to neglect any opportunity to learn from the other fellow's experience. This applies not only to members of the governing bodies, but to all the 'key' officials as well. League Conference programs offer so much to the conscientious public official attendance at all sessions should be a required part of his job."





## SPOTLIGHT ON: ATLANTIC COUNTY

21 Stories of Our Garden State; 21 Stories to say "We're Great"



As early New Jersey settlements grew and developed, each had their own unique identities. In February of 1837, Atlantic County (formerly known as Egg Harbor) was carved from Gloucester County with boundaries that have remained substantially the same to this date. The county is bounded on the north by the Mullica River; on the south by the Great Egg Harbor Bay and the Tuckahoe River; on the west by Camden and Gloucester Counties; and on the east by the Atlantic Ocean. The County Seat was established in Mays Landing in 1837 and a courthouse built there in 1838 where it remains in use today. The first Board of Freeholders was established in 1837 in Mays Landing with representatives from four townships: Galloway, Hamilton, Egg Harbor and Weymouth. As townships and municipalities grew, the board grew as well. In 1967, the State Legislature changed the size to a seven-person-at-large County Board until 1975 when a new charter came into effect. The County governmental form changed from Optional County Charter Law to the Executive Form in 1974.

Today, Atlantic County land area covers 561.01 square miles and is incorporated into 23 municipalities. Estimated county population in the 1994 census was 232,231. The roots of local government in Atlantic County are long-standing. While community sizes and government forms vary, the commitment to citizen-service is well-developed and still a matter of pride. The Atlantic County Park System reflects ongoing commitment to the preservation of open space and the provision of ample opportunities for outdoor recreation. The Atlantic County Park System offers a wide variety of recreational and leisure pursuits. Park programs include group events, crafts, environmental education, and children's programs. At present, Atlantic County has thirteen parks, mostly acquired through New Jersey Green Acres funding.

ATLANTIC CAPE COMMUNITY COLLEGE is a comprehensive two-year public institution serving the residents of Atlantic and Cape May counties, enrolling nearly 6,800 students. ATLANTIC COUNTY INSTITUTE OF TECHNOLOGY is the most comprehensive technical education facility in Atlantic County. ## THE RIGHT OF FREE SPEECH AT COUNCIL MEETINGS

How many of you have been at a Council meeting where a resident gets up to address the Council and rambles off-subject or personally attacks members of the Council or Municipal Staff? When chided by the Mayor or presiding officer, the resident (and taxpayer, they are quick to remind you) asserts the right of free speech and charges that his First Amendment rights allow him to say any-thing he wants.

We are generally familiar with the First Amendment of the United States Constitution which indicates that Congress shall make no law abridging the freedom of speech. Probably less known is the New Jersey Constitution (Article 1  $\P$  6) which states, in part, "Every person may freely speak, write and publish his sentiments on all subjects, being responsible for the abuse of that right. No law shall be passed to restrain or abridge the liberty of speech or of the press".

Despite some popular misunderstanding, the right of free speech is <u>not absolute</u>. You cannot utter terroristic threats, cry "fire" in a crowded movie theater, disseminate certain obscene material, or libel/slander someone without consequences.

Generally our Courts analyze the State Constitutional protection for free speech by relying on Fed-

eral First Amendment principles. New Jersey also recognizes that the right of free speech does not mean that everyone with opinions or beliefs may express them at any time or in any public place of their choosing. In fact, it is a disorderly person's offense if an individual, with purpose to prevent or disrupt a lawful meeting, commits an act intending to obstruct or interfere with it physically.

It has been held that words alone do not automatically satisfy the proscription of the statute but must be accompanied by other acts which create the obstruction or the interference. Speech might qualify as such an act but the speech would have to be of a character intended to disrupt the meeting and capable of doing so. We have come a long way since 1925 when an individual was prosecuted for calling a Council member a "bootlegger" and "soup head". Presumably our elected officials are of tougher stuff than in previous times.

We also know that since 1964, in the U.S. Supreme Court case of <u>New York Times v. Sullivan</u>, public figures and public officials must withstand greater verbal or written abuse than the average person. An elected official, for example, would have to prove the actual malice of the person making the comments or prove that the person had a reckless disregard for the truth, in making them. This is so because the underlying principle of "enhancing the market place of ideas" is placed as a higher value then the libel/ slander protection afforded those in public life. In the balancing of First Amendment rights on issues of public importance or public affairs, and the right of an individual to secure and maintain one's reputation, the latter must yield to some degree to the former. It is also true that the identity or philosophy of the speaker and the subject matter of the speech must be treated with maximum tolerance, and preferences should not be given to supporters over detractors.

In the balancing of First Amendment rights on issues of public importance or public affairs, and the right of an individual to secure and maintain one's reputation, the latter must yield to some degree to the former. Nevertheless, as a general proposition, time, place and manner restrictions even on protected speech are valid provided they are justified without reference to the content of the regulated speech, they are narrowly tailored to serve a significant governmental interest, and they leave open ample alternative channels for communication of the information. It is also understood that government may prohibit all forms of communication in non-public forums as long as the ban is reasonable and content neutral, meaning that the suppression of the speaker's activity is not due to disagreement with the speaker's views. Conversely, regulations relating to suppressing or limiting speech in public forums (technically, in Latin, <u>fora</u>) receive higher scrutiny by our Courts.

So where does all this leave us at a public Council meeting? The strong stated policy of transparency in government in New Jersey is reflected in the Open Public Meetings Act and the Open Public Records Act which provide for public comment and acquisition of information, respectively, by citizens.

As a general rule of thumb, unless specifically exempted, information is open to public scrutiny and comment unless there is a compelling State interest to the contrary. (As one oft-cited example of this on the Federal level, troop movements in the time of war need not and should not be disclosed for the obvious reasons of safety and security of the troops and the strategic policy of the military. On a local level, think stake-outs, unmarked cars, etc.).

Generally speaking, therefore, when an individual seeks to address the Council, First Amendment implications compel allowing the resident to speak on virtually any subject touching on Municipal affairs. If in the course of that presentation, the resident wishes to chastise, attack, criticize, disagree with, or otherwise be negative to Council members and/or Municipal policies, it is his/her right to do so.

Remember, in comparing the significant policy reasons for First Amendment freedoms with an obnoxious or boorish presentation, the First Amendment wins out every time – as it should. It is only when the speaker's comments intentionally "step over the line" to disrupt the meeting that there is a limitation on the speaker's right to speak. This can only be determined on a case by case basis dependent on the facts.

If Council members or staff are slandered, they bear a high burden to be successful under the <u>New York Times</u> case.

Nevertheless, Council members and staff also have First Amendment rights and have the right to refute or defend themselves if they so choose. It has been my experience that the more repugnant the comments are by the speaker the more they should be refuted by facts rather than a response on the same level. In the end, the public will determine in the "market place of ideas" which side has greater validity in their position.

Alternatively, under the current status of the law, while members of the public are entitled to speak at public meetings, there is nothing that compels government officials or employees to engage in a dialogue. Additionally reasonable time limitations imposed uniformly on all speakers are valid.

In the end, for Municipal Clerks facing a particularly nasty onslaught: tolerance, a thick skin and a good sense of humor will get you through.


