# **MCANJ SCHOLARSHIP APPLICATION**

CMC and MMC Scholarship candidates must also be tenured Municipal Clerks; however, if none apply, consideration will be given to non-tenured clerks. These Scholarships will be awarded at the MCANJ Annual Conference. Scholarships to the Annual Conference will be awarded prior to the conference.

Scholarships awarded for RMC, CMC and MMC Programs during one fiscal year may be carried over until the end of the succeeding fiscal year. In order to receive a scholarship, the applicant must show proof of registration prior to the program or proof of attendance if application is made after the program. Failure to attend the program after the award of scholarship will result in reimbursement due to MCANJ. It is the responsibility of the MCANJ Scholarship Committee to present the names of scholarship winners to the Executive Board at least four weeks prior to the Annual Conference.
