## PRESIDENT KAZMARK

Adopt/Amend 2015/2016 MCANJ Budget

The projected IIMC conference revenue is \$18,075.00 and projected expenses are \$17,820.00. RFP for Legal Counsel

1<sup>st</sup> Vice President Szabo had previously distributed a draft RFP document for MCANJ Legal Counsel. Immediate Past President Mitch presented questions on current legal counsel rates, potential travel rate, availability for presidential disturbances, and Quill article preparation. Executive Director Popkin reported some historical data on MCANJ Legal Counsel fees. Discussion amended the following RFP items;

- MCANJ Legal Counsel would attend the Executive Board meetings at the direction of the President on an as needed basis
- Line #11 regarding preparation of a Quill article would be removed from the RFP. Attorney Lustgarten had requested to continue preparing an article for the quarterly MCANJ Quill.
- The Executive Board shall be meeting on 22 January 2016 in Woodland Park and conduct said interviews on that date
- The deadline to receive proposals by 1<sup>st</sup> Vice President Szabo shall be Tuesday, 15 December 2016.

It was agreed that the RFP will be advertised on the NJLM Website; on the MCANJ website; Executive Director Popkin suggested a posting on a Municipal Attorney website; an e-blast to the MCANJ membership; and, copy to Attorney Richard Lustgarten as well.

A conference call of 18 December 2016 at 2:00 pm shall be coordinated to review those applications received. It was stated the Executive Board intention is to interview 3-5 candidates at the 22 January 2016 meeting in Woodland Park
